INDICTMENT

FOR: CONSPIRACY, 21 O.S. § 421

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

On August 19, 2003, by order of the Supreme Court of Oklahoma entered on the 3rd day of July, 2003, the Ninth Oklahoma Multicounty Grand Jury was convened with its principal site to be Oklahoma City, Oklahoma County, Oklahoma, to serve from that date until February 20, 2005, said term of the Multicounty Grand Jury beginning on August 19, 2003, and continuing thereafter, that the said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law and then and there examined, impaneled, sworn and charged according to law to diligently inquire into and true presentment make of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath and in the name and by the authority of the State of Oklahoma, do present and find that:

COUNT I:

On or about the 1st day of July, 2002 through the 31st day of August, 2002, the defendant, AARON ORLANDO GORDON, aka "LANDO" GORDON, did commit the crime of **CONSPIRACY TO COMMIT FORGERY IN THE SECOND DEGREE** in Tulsa County, State of Oklahoma. That is to say that within said period of time and within said county and state, the defendant, AARON ORLANDO GORDON, aka "LANDO" GORDON, did enter into an agreement with one Cheriba Pete and other persons to commit the crime of Forgery in the Second Degree. The defendant, AARON ORLANDO GORDON, aka "LANDO" GORDON, and Cheriba Pete and other persons entered into said agreement prior to the commission of the crime of Forgery in the Second Degree.

Part of this agreement was for the defendant, AARON ORLANDO GORDON, aka "LANDO" GORDON, to supply Cheriba Pete and other persons with counterfeit payment vouchers of the Oklahoma Department of Corrections, which the defendant knew to be counterfeit, purporting to direct the State Treasurer to pay certain sums of good and lawful U.S. currency to "Christy Davis." In furtherance of the conspiracy, the defendant, AARON ORLANDO GORDON, aka "LANDO" GORDON, provided transportation for Cheriba Pete and other persons to various merchants for the purpose of Cheriba Pete and other persons to utter said counterfeited vouchers to the merchants in exchange for good and lawful U.S. currency. In furtherance of the conspiracy, the defendant provided a false identification card to Cheriba Pete in the name of "Christy Davis." In furtherance of the conspiracy, Cheriba Pete and other persons provided the defendant with good and lawful U.S. currency obtained from the utterance of the counterfeit vouchers. In furtherance of the conspiracy, the defendant paid to Cheriba Pete and other persons approximately one hundred dollars

(\$100.00) for each of the counterfeit vouchers uttered. Subsequent to the formation of said agreement, the following overt acts were performed:

1. On or about the 19th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Wal-Mart store in the city of Ada, county of Pontotoc, state of Oklahoma, in the amount of six hundred twenty-one dollars (\$621.00).
2. On or about the 24th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Super H store located in the city of Tulsa, county of Tulsa, state of Oklahoma, in the amount of two hundred thirty-six dollars and twenty-six cents (\$236.26).
3. On or about 24th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Albertson's store located in the city of Stillwater, county of Payne, state of Oklahoma, in the amount of two hundred thirty-six dollars and twenty-six cents (\$236.26).
4. On or about 24th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Stillwater Food Outlet store located in the city of Stillwater, county of Payne, state of Oklahoma, in the amount of three hundred seventy-two dollars and one cent (\$372.01).
5. On or about the 25th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Plaza Red

- Bud, Inc. in the city of Tulsa, county of Tulsa, state of Oklahoma, in the amount of three hundred seventy-two dollars and one cent (\$372.01).
6. On or about the 28th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Wal-Mart store located in the city of Poteau, county of LeFlore, state of Oklahoma, in the amount of four hundred forty-two dollars and thirteen cents (\$442.13).
 7. On or about the 28th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Marvin's Foodsaver store located in the city of Muskogee, county of Muskogee, state of Oklahoma, in the amount of three hundred seventy-two dollars and one cent (\$372.01).
 8. On or about 28th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Price Cutter #347 store located in the city of Poteau, county of LeFlore, state of Oklahoma, in the amount of two hundred forty-one dollars and eleven cents (\$241.11).
 9. On or about the 28th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Albertson's store located in the city of Muskogee, county of Muskogee, state of Oklahoma, in the amount of two hundred forty-one dollars and eleven cents (\$241.11).

10. On or about the 28th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Homeland #880 store located in the city of Muskogee, county of Muskogee, state of Oklahoma, in the amount of two hundred forty-one dollars and eleven cents (\$241.11).
11. On or about the 29th day of July, 2002, Cheriba Pete offered a counterfeit voucher, provided to her by the defendant, for consideration to the Marvin's Food Warehouse store located in the city of Sallisaw, county of Sequoyah, state of Oklahoma, in the amount of four hundred forty-two dollars and thirteen cents (\$442.13).

All of the foregoing being committed contrary to Section 421 of Title 21 of the Oklahoma Statutes and against the Peace and Dignity of the State of Oklahoma.
