COUNT 1 FUGITIVE FROM JUSTICE, ~ 21 O.S. § 1141.13 a FELONY

STATE OF OKLAHOMA, COUNTY OF CLEVELAND:

I, E. SCOTT PRUIT, the undersigned Attorney General of the State of Oklahoma, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Cleveland and in the State of Oklahoma, KRISTIN AMANDA BURNS and there unlawfully, willfully, knowingly and wrongfully commit the crime of:

COUNT 1: FUGITIVE FROM JUSTICE ~ 21 O.S. § 1141.13, a FELONY. That is to say, the said Defendant, on or about the 11th day of March, 2013, being then and there a fugitive from justice of the State of Florida, County of Seminole, the said defendant being then and there charged with the commission of the crimes of:

1. Racketeering (one count);
2. Conspiracy to commit racketeering (one count)
3. Money Laundering (four counts)
