
Background

The Oklahoma Opioid Overdose Fatality Review Board was developed from a recommendation by the Oklahoma Commission on Opioid Abuse through House Bill 2798 in 2018. The 20-member Board, chaired by Dr. Jason Beaman, is comprised of a multidisciplinary team of subject matter experts in the following areas: forensic medicine, law enforcement, criminal justice, emergency medical services, public health, drug addiction treatment and recovery, and lived experience. Members meet quarterly to review cases and develop strategies to improve the state's response to opioid overdose.

Due to health concerns as a result of the COVID-19 pandemic and due to the expiration of the amendments to the Oklahoma Open Meeting Act which allowed virtual meetings, the Board was unable to convene a quorum of members in January 2022 in order to adopt a final report. As a result, I am submitting this document to report on the work of the Board for 2021. An adopted final report offering recommendations regarding legislation and other preventative measures based on case review findings will be supplied as soon as the group is able to safely conduct business. Until then, this remains only a Chairman's Report.

Unintentional Opioid Overdose Fatality in Oklahoma


Data from the Oklahoma State Department of Health, Injury Prevention Services show that in 2020 there were 733 drug overdose fatalities in Oklahoma, an increase of 24% from 2019 (Figure 1). This includes a 170% increase in the number of fentanyl deaths from 2019 to 2020 with more fentanyl overdose deaths appearing to involve illicitly manufactured fentanyl than in previous years.



In 2020, the most common substances listed as the primary cause of death in unintentional drug overdose deaths included opioids and methamphetamine. Methamphetamine accounted for the highest number of deaths followed by opioids and benzodiazepines. Of the overdose deaths involving opioids, 77% involved fentanyl and/or heroin (Figure 2). Due to the dramatic increase in unintentional overdose deaths involving fentanyl, the Oklahoma State Department of Health is no longer reporting the number of overdose deaths involving prescription opioids.

From 2016-2020, unintentional overdose deaths occurred among males at higher rates than females in all age groups. The highest rates were in the 35-44 year old age group for males and 45-54 year old age group for females. The male and female rates become comparable in the 45-54 year old age group (Figure 3).



Overview

The Oklahoma Opioid Overdose Fatality Review Board held three public meetings in 2021. Due to health concerns presented by the COVID-19 pandemic the Board was unable to meet in person in January of 2021. Changes to the Oklahoma Open Meeting Act allowed the Board to convene virtually in April 2021. In July 2021, decreasing COVID-19 rates allowed the Board to safely convene in person for the remainder of the year. The following is a brief summary of the 2021 meetings.

Board Activities 2021

During the 2021 meetings, the Board was presented with multiple resources related to opioid overdose education and prevention, conducted nine case reviews, and developed recommendations based on information obtained during case review. In November 2021, the Board welcomed two new members from the Association of the Oklahoma Narcotic Enforcers and the Oklahoma State Board of Pharmacy as outlined in SB94.

Senior Deputy Attorney General Lori Carter provided an update on opioid related legislation from Oklahoma's 2021 legislative session including an overview of the following bills:

All signed by Governor:

- HB1567 by Representative Boardman and Senator Weaver
 Creates aggravated trafficking offense for fentanyl, heroin, LSD and PCP and clarifies that any person convicted must serve 85% of sentence before being parole eligible.
- HB2676 by Representative Marti and Senator Weaver Allows controlled dangerous substances issued by a practitioner to be dispensed with an electronic prescription if certain conditions apply. The measure also allows electronic prescriptions to be utilized for compounded prescriptions, compounded infusion prescriptions, and prescriptions issued under approved research protocols.
- SB57 Senator Rader and Representative Echols
 Grants Opioid Overdose Fatality Review Board access to the PMP and clarifies the exemption for cancer treatment hospice providers
- SB58 Senator Rader and Representative Echols
 Provides an exemption to the electronic to the prescribing requirement for practitioners
 who administer a controlled dangerous substance through a hospice program

SB94 Senator Hall and Representative Mize

Adds the President of the Association of the Oklahoma Narcotic Enforcers and the Executive Director of the State Board of Pharmacy or designee to the OOFRB.

Carried Over:

SB241 Senator Thompson and Representative Kannady

Amending reporting requirements for every registered manufacture and distributor of controlled dangerous substances by requiring schedule II though V to be reported to the OBN. in the same format as reported to the Federal Drug Enforcement Administration.

SB605 Senator Thompson and Representative Kannady

Amending reporting requirements for every registered manufacture and distributor of controlled dangerous substances by requiring schedule II though V to be reported to the OBN. in the same format as reported to the Federal Drug Enforcement Administration.

SB888 Senator Standridge and Rep Echols

Mandates registration with the State Board of Medical Licensure for pain clinics.

Vetoed:

HB2510 Rep Kannady and Sen Thompson

Modifies and clarifies disbursement procedures for the Opioid Abatement Funds

The Board also discussed and voted to: approve the recommendations for the 2021 Oklahoma Opioid Overdose Fatality Review Board Annual Report and elected District Attorney Chris Boring as the new Vice Chair of the Board.

Board Findings 2021


The Board reviewed nine cases of individuals who died from unintentional opioid overdose between July 2020 and April 2021.

Demographics

Of the cases reviewed, 78% (7) were men and 22% (2) were women. Decedents ranged in age from 21 to 63 years with the average age of 38 years. The majority of decedents reviewed were White (56%), and between the ages of 36 to 45 (56%) (Figure 4).

Decedents from reviewed cases resided in 7 Oklahoma counties: Comanche (2); Garfield (1); Garvin (1); Grady (1); LeFlore (1); Oklahoma (2); and Tulsa (1) (Figure 5).

Cause of Death by Drug Type

The Oklahoma Office of the Chief Medical Examiner investigates and determines manner and cause of death. The manner of death for all cases reviewed was accidental, and the primary cause of death included at least one opioid (illicit and/or licit).

Illicit opioids were listed as the primary cause of death in all 9 cases, including fentanyl (6) and heroin (3). Prescription opioids were listed in the primary cause of death in 1 of the cases reviewed. The majority of cases 67% (6) listed more than one drug as the primary cause of death. In 6 of the cases reviewed, additional substances were listed in the primary cause of

death including an opioid plus methamphetamine (4), opioid plus benzodiazepine (2), and opioid plus cocaine (2).

Education Level, Marital Status, and Military Service

It was reported that 88% (7) of decedents in the cases reviewed had a high school diploma or less and 12% (1) had a bachelor's degree. Half (4) were never married; 38% (3) were divorced; and 12% (1) was married at the time of their death. None of the decedents in the cases reviewed were reported to have served in the military. Data on education level, marital status, and military service was not available for 1 of the cases reviewed.

Criminal Justice Involvement

Of the cases reviewed, it was reported that 78% (7) were criminal justice involved at least once in their lifetime.

Domestic Violence

Fifty-six percent (5) of the decedents reviewed had a documented history of domestic violence. Of those 5 cases, 5 male decedents were reported to be perpetrators of domestic violence.

Conclusion

The work of the Board, the work of the review process, and the development of data-informed recommendations is vital in combatting and reducing opioid overdose deaths in the state of Oklahoma. The members of the Board are dedicated to preventing the loss of our fellow community members to opioid overdose and look forward to continuing these efforts in 2022.
