| <b>Mary Bobek</b>    | Abuse by Caretaker<br>21 O.S. § 843.1                  | Defendant was working as a certified nurse aide. The Defendant placed a gait belt around the victim's waste and wheelchair without her written consent or a physician's order.  | December 6, 2018   | Caretaker              | Kingfisher |
| <b>Herbert Horne</b> | Neglect by Caretaker<br>21 O.S. § 843.1                | Defendant was the Power of Attorney and Guardian of his father and failed to provide adequate medical care. Defendant lived in the same home with his father and was acting as his caretaker. The victim was transported to the hospital with very poor health including thin skin, stage III and IV decubitus wound with eschar. He was emaciated and was soiled with bodily waste. Medical experts testified that this condition occurred over time and was left untreated. | September 21, 2018 | Son                    | Oklahoma   |
| <b>Brandi Horne</b>  | Neglect of a Vulnerable Adult<br>21 O.S. § 843.3       | Defendant was engaged to Herbert Horne and was a frequent guest in the residence where the victim was located. Defendant was a registered nurse and failed to render aid or report the neglect of the victim.   | September 21, 2018 | Daughter in law        | Oklahoma   |
| <b>Tracy Borman</b>  | Financial Exploitation by Caretaker<br>21 O.S. § 843.1 | Defendant, working as a nurse aide, obtained the debit card of a resident. Defendant used the card to purchase personal items, pay medical bills and withdraw cash.   | July 13, 2018      | Caretaker              | Tulsa      |

| <b>Stephanie Llanes</b> | Neglect by Caretaker<br>21 O.S. § 843.1   | Defendant and another certified nurse aide were assigned to care for a resident who needed a Hoyer Lift for transferring from the bed to a chair. Instead of using the lift, the two co-defendants unsuccessfully attempted to lift the resident by her arms. The resident dropped to the floor and broke her leg. Both aides failed to report the fall and provide immediate medical care. | June 14, 2018      | Caretaker              | Tulsa    |
| <b>Bobbie Pearson</b>   | Neglect by Caretaker<br>21 O.S. § 843.1   | Defendant was assigned to the feeding and medication of a nursing home resident. Video installed by the family showed the Defendant neither fed nor administered medications to the victim during her entire 7:00 a.m. to 11:00 p.m. shift.   | May 30, 2018       | Caretaker              | Oklahoma |
| <b>Edward Dominic</b>   | Abuse by Caretaker<br>21 O.S. § 843.1   | After Defendant was terminated from a nursing home, he returned to the facility for the purpose of obtaining Fentanyl patches from residents. Defendant physically removed the pain patch from a resident and left the facility.  | May 11, 2018       | Caretaker              | Garfield |
| <b>Richard Edwards</b>  | Abuse By Caretaker<br>21 O.S. § 843.1<br><br>Verbal Abuse by Caretaker<br>21 O.S. § 843.2 | Defendant was a nurse aide responsible for the care of the victim who suffered from traumatic brain injury. Defendant ridiculed and derided the victim and his elderly wife. While cleaning the victim, Defendant caused the victim to fall out of bed and hit his head on the nightstand.  | January 9, 2018    | Caretaker              | Creek    |
| <b>Jamie Rodman</b>     | Neglect by Caretaker<br>21 O.S. § 843.1   | Defendant was working as a certified nurse aide while under the influence of hydrocodone, placing the residents at an unreasonable risk of harm.  | January 9, 2018    | Caretaker              | Creek    |
